THIS AGREEMENT is entered into on _____, **2025**, by and between **Max Maxwell Motorsports & Driving School, Inc.** (hereafter referred to as "**MMDS Inc.**") and _____ (parent/guardian name if below age 18.)

In consideration of the mutual promises of the parties and of other good and valuable consideration, it is agreed:

1. MMDS Inc. will conduct an instructional driving program (Differential Driver Training Program) for _____ (student's name).
2. The cost is \$2800.00 for the 58-hour program.
3. By enrolling in the Differential Drivers Training Program, and its execution of this agreement, _____ (parent or guardian's name if under age 18) successors and assigns, agrees to defend, indemnify, and hold harmless MMDS INC., as well as any legal or beneficial owners, lessees, licensees, or any other person or entity having property or contract rights in the premises used for the Program (hereinafter referred to as "premises owners"), from and against any claim, demand, suit, judgment, costs or fees, including attorneys' fees, damages, or other liabilities relating to or arising out of the activities, directly or indirectly connected with the Program or relating to or arising out of use of any property or facilities provided, operated, or controlled by MMDS INC. or premises owners, whether arising while the Student is engaged in the Program or in preparation for it, or while upon the premises of the instructional driving area.
4. **Parent or guardian participation is encouraged for the program. Parent involvement is critical for the student's success.**
5. If an accident or motor vehicle crash occurs for which the student is responsible, in whole or part, the student will be responsible for the deductible, costs, fees, and expenses resulting from the crash.
6. Tennessee State Law requires 50 hours of supervised driving completed, 10 of those hours being at night prior to receiving the intermediate license.
7. **MMDS INC. cannot guarantee that the student, upon completion of instruction, will pass the Tennessee State Written Test.**
8. **MMDS INC. cannot guarantee that the student, upon completion of instruction, will receive any type of license.**

eligible for any discount from any insurance company. It is the student's and parent's responsibility to check for compliance to the rules and regulations of their insurance company.

10. MMDS INC. agrees to hold classes and driving at a location as specified by MMDS INC. and the student agrees to come to a specified location at a specified time and date for the driving instruction and for the classroom instruction.
11. Student must be picked up promptly at the conclusion of every classroom session and driving lesson. MMDS INC. will not be held responsible for any student left after the classroom session and driving lesson has ended.
12. Classroom instruction is held at the Agricenter International Wing C in a classroom designated by the instructor.
13. MMDS INC. requires that all 30 hours of classroom time be completed before any driving lessons begin. Any classroom time missed is required to be made up.
14. **It is understood that during the 10 days of classroom instruction, the student will not do any driving lessons with MMDS INC.**
15. **Student agrees to abide by any and all rules and regulations, written or oral, set forth by MMDS INC. If the student fails to abide by rules and regulations set forth, written or oral, student will be dismissed from the Maxwell Driving School Differential Driver Training Program and student forfeits 100% of tuition.**
16. MMDS INC. will give parent and student available dates, time, and location for the driving instruction part of the program. It is the parents and student's responsibility to know the dates, time, and location for the driving instruction part of the program.
17. It is the responsibility of the student to complete all of the hours of driving instruction within one year from first class date.
18. For all on the road driving lessons, the student will meet the instructor outside of Wing C where the driving school cars are parked. Student should not wander around the parking lot or inside the building prior to driving lesson. Instructor is not able to search for student. It is the student's responsibility to be on time, in designated area for driving lessons.
19. **Student must be on time for all driving lessons. Driving lessons must be rescheduled by contacting the instructor via email at heidwww1974@gmail.com or by contacting the office during office hours.**
20. Medical reasons, illness, and death/emergency in the family are the only excusable reasons for a missed scheduled driving lesson.

In consideration of MMDS Inc. affording the student the opportunity to participate in the Program, student hereby forever releases, waives, and indemnifies MMDS Inc. and all of its supporters from and against any and all claims, lawsuits, damages, liabilities or expenses (the "Claims") arising from the participation of the student in the Program.
25. The rules and regulations of The Tennessee Department of Safety are available for your review in the office.
- 26. MMDS, INC. has a strict NO HARRASSMENT and NO BULLYING policy. Any student harassing or bullying another person will be dismissed from the program and NO refund will be given.**
- 27. MMDS INC. does NOT allow ANY form of electronic device in the classroom.**
28. I, Parent and Student hereby grants MMDS Inc. the right to photograph, record, broadcast, telecast, and use in perpetuity throughout the world in all media now and hereafter known or devised: name, likeness, recorded voice, performance, picture, nickname and any material furnished by me in connection with any use whatsoever, including but not limited to the promotion of newsletter(s), advertisement(s), brochure(s), media coverage and television program(s) connected herewith, Student also releases MMDS Inc. and any of its assignees from any and all claims for libel, slander, invasion of privacy, or any other claims based upon use of the above-described material.
29. This release shall be governed by the laws of the State of Tennessee without regard to its conflicts of law's provisions. If any part of this release is deemed invalid, unenforceable, or void for any reason, all other parts of this release shall remain in full force and effect.
30. The student acknowledges that the program exposes the student to serious injury or death to his person, also to student's property. **The student acknowledges that they are fully aware of the risks inherent in the program and because the student desires to enter such program. Student specifically assumes all such risks inherent in such an instructional driving program.** Furthermore, the student's participation in the program shall affirm the student's inspection and acceptance of the physical properties of the program course and the grounds adjacent thereto, as being satisfactory for purposes of the student's assuming all risks
