Hereinafter collectively referred to as the “Student” and the “Parent.” In consideration of the promises herein and other good and valuable considerations, the Parties agree as follows:

Program Overview

Maxwell Motorsports & Driving School (MMDS Inc.) offers professional defensive driver education through structured training programs. Courses include classroom instruction, simulator training, and hands-on driving lessons tailored to TN State requirements.

Tuition & Payments

Program Options:

- 36-Hour Program: \$656.00
- 40-Hour Program: \$866.00

Payment Terms:

- Tuition is due in full at registration unless MMDS approves other arrangements in writing.
- Students may not begin classroom or driving sessions until tuition is paid.

Refund Policy:

- More than 2 weeks before class: 100% minus \$53 administration fee
- 1-2 weeks before class: 50% refund
- Less than 1 week before class or no-show: No refund
- Once the student attends any part of the classroom or driving instruction, no refund is available.
- Missed time or withdrawal from the program after beginning instruction does not reduce tuition.

- Late Registration (same day): \$25.00
- Returned Check: \$50.00
- Late Payment (monthly): \$25.00
- No-Show for Driving Sessions: \$79.00
- Late Cancellation of Driving Sessions: \$53.00
- TN Road Test (optional): \$63.00
- MMDS Inc. reserves the right to add a fuel surcharge, due to rising fuel costs.

Eligibility & Requirements

- Safe participation in behind-the-wheel driving instruction requires the Student to be fluent in **both spoken and written English**. The Student must be able to immediately understand, process, and respond to verbal and written instructions, safety commands, traffic-related terminology, and corrective guidance provided by the instructor.
- Driving lessons **cannot** be conducted through interpreters, translation applications, electronic translation devices, or third-party assistance of any kind.
- If, at any time, MMDS determines that a language or communication barrier compromises the safety of the Student, the instructor, or the public, MMDS reserves the right to suspend or discontinue instruction immediately. **Instructional fees shall not be refunded** in such circumstances.

Code of Conduct & Classroom Policies

- Students must behave respectfully and maintain a clean learning space.
- Students are assigned seats and must clean their area of trash, food, gum, and other debris after each class.
- Cell phones are not allowed. Students must place their phone in a designated bin during the entire duration of the instruction day. Repeated violations may result in dismissal.
- Absences from classroom instruction must be made up in the next available session.
- Students must be picked up promptly after class or driving sessions.

Scheduling & Driving Sessions

- Students must complete the program within **6 months** of the first classroom day.
- Drive times fill quickly—schedule early.
- Parents and Students are responsible for knowing the dates, times, location, and instruction type the Student is participating in.
- No-shows (arriving 10+ minutes late or not showing up): **\$79 fee**
- Cancellations within 48 hours: **\$53 fee**
- Reschedules must be made online or in-person. No phone changes allowed.
- All fees must be **paid in full** before the Student's next driving session.
- All fees must be **paid in full** to receive the Certificate of Completion or other necessary documentation.
- The optional TN Road Test must be scheduled within **1 year** of the Student's final driving lesson.

Expectations & Responsibilities

- Students must attend all scheduled sessions **on time** and be prepared.
- Parents are responsible for ensuring their teens complete at least **50 hours** of supervised practice, *including 10 hours* at night.
- Parents and Students are responsible for obtaining a Learner's Permit.
- MMDS Inc. does not guarantee public road driving if the student lacks readiness.
- MMDS Inc. **reserves the right to terminate instruction** at any time if a Student is non-compliant, uncooperative, or driving in a way that is deemed unsafe. In such cases, no refund will be issued.
- MMDS Inc. does not guarantee the Student, upon completion of instruction, will pass the Tennessee Knowledge Test or the Tennessee Road Test.
- MMDS Inc. does not guarantee the Student, upon completion of instruction, is eligible for discounts from their insurance company.
