Private Lessons Agreement

This Agreement is entered into on the _____ day of _____, 2026, by and between Maxwell Motorsports & Driving School, Inc. ("MMDS") and:

Hereinafter collectively referred to as the "Student" and the "Parent." In consideration of the promises herein and other good and valuable considerations, the Parties agree as follows:

1. Instruction Provided

- MMDS will provide instructional driving lessons for the Student.
- A minimum of three (3) lessons is required for all new Students.
- Each lesson is billed at \$85.00 per hour, with each lesson lasting one hour unless otherwise specified.

2. Payment & Refund Policy

Instructional fees are non-refundable once MMDS is ready, willing, and able to provide the scheduled service. Prepaid lessons expire **12 months** after the date of purchase unless otherwise agreed in writing.

3. No-Show & Cancellation Policy

- A minimum of 48-hour notice is required to cancel or reschedule any lesson.
- Students who miss a scheduled lesson without proper notice will forfeit that lesson and must purchase a new lesson to continue training.
- Students who arrive late may choose to complete the lesson within the remaining scheduled time **or** pay a \$53.00 rescheduling fee to move the lesson to another date.
- Repeated no-shows or late arrivals may result in dismissal from the program at the School's discretion.

4. Eligibility

- Safe participation in behind-the-wheel driving instruction requires the Student to be fluent in **both spoken and written English**. The Student must be able to immediately understand, process, and respond to verbal and written instructions, safety commands, traffic-related terminology, and corrective guidance provided by the instructor.
- Driving lessons **cannot** be conducted through interpreters, translation applications, electronic translation devices, or third-party assistance of any kind.
- If, at any time, MMDS determines that a language or communication barrier compromises the safety of the Student, the instructor, or the public, MMDS reserves the right to suspend or discontinue instruction immediately. **Instructional fees shall not be refunded** in such circumstances.
- MMDS does not guarantee that lesson completion will qualify the Student to obtain a learner's permit, pass a road test, or meet any state licensing requirements.

5. Property Damage & Accidents

Students and/or Parents are responsible for any damage caused to MMDS vehicles, equipment, or Agricenter property. If the Student causes a collision during a lesson, the Parent/Student agrees to pay the insurance deductible, and any costs not covered by insurance.

6. Liability & Indemnification

By participating in instructional driving lessons, the Student and Parent agree to release, defend, indemnify, and hold harmless MMDS, its employees, agents, owners, and successors, as well as the owners of any premises or vehicles used for instruction. This includes all claims, demands, suits, attorney fees, costs, or damages arising directly or indirectly from lessons or the use of school vehicles, property, or facilities. This indemnification applies during instruction, travel to/from instructional sites, and any time the Student is on School premises.
